



Message of the WHO Regional Director for Africa, Dr Luis Sambo on the occasion of the Eighth African Traditional Medicine Day, 31st August 2010

Tomorrow, 31st August 2010 is a milestone in traditional medicine in Africa as we celebrate the Eighth African Traditional Medicine Day. This annual event also coincides with the commemoration of ten years since the adoption, in Ouagadougou, Burkina Faso, of the Regional Strategy on Promoting the Role of Traditional Medicine in Health Systems. Also today, we commemorate the unprecedented Declaration, by Heads of State and Government of countries of Africa that the period 2001-2010 be recognized as the Decade of African Traditional Medicine.

The theme for the commemoration - Decade of African Traditional Medicine: The progress so Far - is of crucial importance in drawing attention to the progress made towards integrating traditional medicine

As we approach the end of the decade, it is gratifying to note that Member States of the African Region have made progress in implementing the Regional Strategy on Traditional Medicine. More than half of the Member States have formulated national policies and regulatory frameworks to ensure the efficacy, safety and quality of traditional medicines and implemented national programmes to institutionalize traditional medicine.



Research has been intensified towards building scientific evidence. The focus of traditional medicine research has been on medicinal plants particularly for the treatment of malaria, opportunistic infections of people living with HIV/AIDS, diabetes, hypertension and sickle-cell disease.

Some Member States are developing national herbal pharmacopoeias to organize scientific information on useful medicinal plants found to be efficacious in the management of certain ailments. Others have produced traditional medicines and registered them with national medicines regulatory authorities. In addition, a number of countries have incorporated traditional medicine in health sciences training curricula.

Even so, for further progress to be made, much more needs to be done in terms of the strengthening of research and institutional capacities and the integration of best practices. Regulations should be better enforced to enhance the safety, quality and efficacy of traditional medicines and practices.

Traditional medicine research and development in the African Region should be further promoted and supported. Emphasis should be placed on further exploitation of the rich and diverse medicinal plant resources in Africa which can contribute to the discovery and development of new medicines. At the same time, traditional medicine knowledge should be preserved and protected. The WHO Global Strategy and Plan of Action on Public Health, Innovation and Intellectual Property, adopted by the Sixty-first World Health Assembly in 2008, should provide a relevant framework for addressing this crucial issue.

To this end, I urge governments, the private sector, civil society, nongovernmental organizations, partners and other stakeholders to increase their contributions to African Traditional Medicine particularly in the area of research to enable it to play its full role in health.

For its part, WHO remains committed to providing support to countries and promoting the development of Traditional Medicine in the African Region. wish you all a successful celebration.

60[™] SESSION OF REGIONAL COMMITTEE OPENS TODAY IN MALABO



The 60th session of the WHO Regional Committee for Africa opens today at the CEMAC Parliament Palace in Malabo, Equatorial Guinea. The Regional Committee, is composed of Ministers of Health of the 46 Member States of the WHO African Region.

From 30th August to 3rd September 2010, Delegates will discuss on a range of health issues including: The work of WHO in the African Region 2008-2009: biennial report of the WHO Regional Director; a strategy for addressing the key determinants of health in the African Region; reduction of the harmful use of alcohol; eHealth solutions; cancer of the cervix in the African Region; Health systems strengthening: Improving district health service delivery, and community ownership and participation; Sickle-cell disease: a strategy for the WHO African Region; Multidrug-resistant and extensively drug-resistant TB.

The Regional Committee will also discuss routine immunization and polio eradication; the global financial crisis: implications for the health sector in the African Region; recurring epidemics and emergency preparedness and response; the framework document for the African Public Health Emergency Fund, among others.

Participants will also provide inputs to the WHO Programme Budget 2012-2013; the future of financing for WHO; the correlation between the work of the Regional Committee, the Executive Board and the World Health Assembly. Other issues on the agenda are: the WHO internal and external audit reports; the current situation of WHO staff in the African Region and the report of the Regional Task Force on the prevention and control of substandard/spurious/falsely-labelled/falsified/ counterfeit medical products in the WHO African Region.

Delegates will also have the opportunity to participate in a panel discussion on Universal access to Emergency Obstetric and Newborn care.
